## **1. Introduction**

Asian University for Women (AUW) seeks to graduate women who will be skilled and innovative professionals, service-oriented leaders in the businesses and communities in which they will work and live, and promoters of intercultural understanding and sustainable human and economic development in Asia and throughout the world.

## **2. Scope of Services**

**a.** Perform pressure grouting beneath the mat using advanced machinery operated by experienced and skilled manpower. The vendor will supply all necessary materials, including high-quality cement and additives required for optimal grout performance. The vendor will also manage the entire power supply and related logistics needed for the grouting operation, ensuring uninterrupted work progress. The grouting process will be carefully controlled to fill voids, cracks, and consolidate the soil, thereby improving the load-bearing capacity and stability of the mat foundation.

**b.** Fabricate and install pressure grouting pipes within the mat through precision core cutting. This involves accurately drilling holes of specified diameter and depth to place the grouting pipes strategically. The vendor will ensure proper sealing and securing of pipes to prevent grout leakage. The installation will be planned to cover all critical areas requiring reinforcement, ensuring thorough grout distribution and effective strengthening of the foundation. All work will comply with relevant engineering standards and safety protocols.

**c.** Conduct pre-grouting site inspection and surveys to identify areas requiring grouting, assess soil conditions, and determine optimal grout mix design.

**d.** Prepare grout mix on-site or at an approved facility, ensuring consistent quality and correct proportions to meet design specifications.

**e.** Monitor grout pressure, volume, and flow rate continuously during injection to achieve uniform distribution and prevent over-pressurization or damage to the mat structure.

**f.** Perform post-grouting inspection and testing, including core sampling and pressure tests, to verify grout penetration effectiveness and structural improvements.

**g.** Provide all necessary equipment for transportation, handling, and disposal of waste materials generated during the grouting process, adhering to environmental and safety regulations.

**h.** Maintain clear documentation and reporting throughout the grouting work, including daily progress reports, material usage logs, and any deviations or issues encountered.

- The vendor is responsible for the fabrication and precise installation of all grouting pipes according to the project specifications using suitable core cutting techniques. Proper sealing and securing of pipes must be ensured to avoid grout leakage.
- The vendor must strictly adhere to all relevant engineering standards, industry best practices, and safety protocols throughout the execution of the work to minimize risks and ensure quality

outcomes.

- Close coordination and communication with AUW's designated site engineer or consultant is mandatory to ensure alignment with project requirements, timely inspections, and addressing of any on-site issues.
- The vendor shall maintain a clean, organized, and hazard-free work environment at all times, including the responsible handling and disposal of waste materials generated during the work.

## **5. Submission Requirements**

Vendors must submit the following documents and details for evaluation:

- A detailed work methodology outlining the step-by-step approach to be used for the grouting work, including quality control measures.

- A competitive financial proposal that aligns with the technical scope provided, without any deviations or omissions.

- The competitiveness and transparency of the pricing offered in relation to the scope.
- The completeness and professionalism of the submission, including all required documents and information.
